New emissions inspector training:

- 1 – The new inspector will take the online training course. This can be located through our website, www.brhd.org, or directly at cacheim.autosciencetech.org. The inspector must enter the course through the "I/M Inspector Login."
- 2 – After the online training is complete, the new inspector will call our office and register for an upcoming in-house training course. The new inspector will do practice inspections during this training.
- 3 – As long as fees are paid, the new inspector will leave the in-house training with an access code and ability to start doing emissions inspections immediately.

Current emissions inspector refresher training:

Certified Emissions Inspectors are required to complete a refresher training course every 2 years. This must be completed no more than 60 days prior to the date of expiration. Notices will be sent to inspectors that are due for training. Inspectors in need of refresher training will call our office and register for an upcoming course.
